

**ALPHA MEDIA'S CONTEST-SPECIFIC RULES FOR THE
WIRK COUNTRY VOICE 2018 CONTEST**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

These contest-specific rules should be read in conjunction with Alpha Media's General Contest Rules, which are applicable to all contests conducted by Alpha Media Holdings LLC and/or its subsidiaries (including licensee subsidiaries).

1. Promotional Period: The Country Voice 2018 Contest (the "Promotion") begins on or around Thursday, February 8, 2018 at 6:00pm eastern time and ends on Thursday, February 22, 2018 at 10:00pm eastern time.

2. Entry Deadline: The deadline to submit entries is Thursday, February 22, 2018 at 7:00pm eastern time.

3. Eligibility Restrictions: The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 21 years of age or older at the time of entry and who live in Indian River, St. Lucie, Palm Beach, Martin, Broward, Dade, counties Employees of 103.1 WIRK-FM (the "Station"), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners, other broadcast stations in the Station's listening area, and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY and FL, as applicable, and where prohibited.

Listeners are eligible to win an Alpha Media contest valued at \$600.00 or more only once every six months.

VIA INTERNET –Go to WIRK.com and follow the links and instructions to enter and submit the required information, which may include your first and last name, address, telephone number, date of birth, and a valid email address, in the online entry form. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible for assigning the email address or the domain associated with the submitted email address. Multiple entrants are not permitted to share the same email address. Entries submitted will not be acknowledged or returned. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's computer is the official time-keeping device for the Promotion.

All entrants must follow the "call to action" entry instructions and submit any requested information. By submission of a text message entry in this contest, entrants hereby expressly consent to the receipt of a confirmatory bounce-back message related to this Promotion. Text message entries will be deemed made by the authorized account holder of the mobile account used to submit the entry at the time of entry. The authorized account holder is the natural person who is assigned to the text or mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. Multiple entrants are not permitted to share the same text or mobile telephone number. Use of any device to automate entry is prohibited. Proof of submission of an entry shall not be deemed proof of receipt by Station. The contest/sweepstakes administrator's telephone system is the official time keeping device for the Promotion.

All entries must be received by 8:00 PM eastern time. The Station is not responsible for lost, stolen, mangled, misdirected, postage due, illegible, incomplete or late entries.

One entry per person.

5. Prizes:

One (1) grand prize will be awarded in this promotion on February 22, 2018 at The Ranch at Double Dee's around 10:00PM. The Grand Prize winner will win a opening slot at WIRK Rib Round Up Concert on Saturday, March 3, 2018.

The prizes are expressly limited to the item(s) listed above and unless otherwise expressly specified, do not include taxes, gratuities or any other expenses. Other restrictions may apply.

6. Odds of Winning:

Odds of winning a Qualifying Prize are 3 in 15. Odds of a Qualifier winning the Grand Prize are 1 in 10.

7. Winner Selection and Notification:

Decisions of Station management with respect to the Promotion are final.

This will be measured by a noise meter provided by WIRK-FM.
- c. Pre-qualifiers must sign in by 7:00PM ET or they will be disqualified from competing that night. As stated in section 1a the station may, at its sole discretion, fill in spaces left by pre-qualifiers who do not check in on time with onsite registrations.
- d. The Grand prize winner will be chosen at The Ranch at Double Dee's [8199 Southern Blvd, West Palm Beach, FL 33411] on February 22, 2018 at 10:00PM.
- e. Contestants must bring their own music on either CD, iPod, Phone, etc. Contestants do not need to sing the full song, but must complete at minimum one

(1) minute and maximum three (3) minutes of singing in order to be eligible to win.
